# RUBBER TRACK WARRANTY POLICY

## Warranty period begins on the date of purchase

15 month or 1000 hours, whichever comes first, with no prorating in the first 8 months. Prorating begins in the ninth month and is based on the following percentages:

- Additional coverage may be issued based upon the determination of the claim.

24 month or 1500 hours, whichever comes first, with no prorating in the first 12 months. Prorating begins in the thirteenth month and is based on the following percentages:
